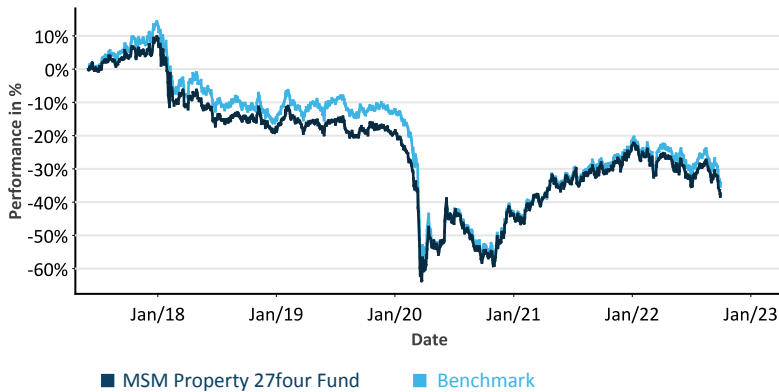


Cumulative Returns Since Inception

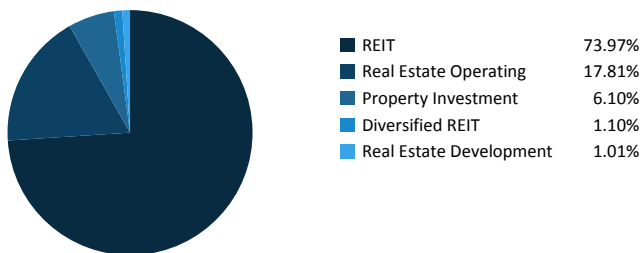

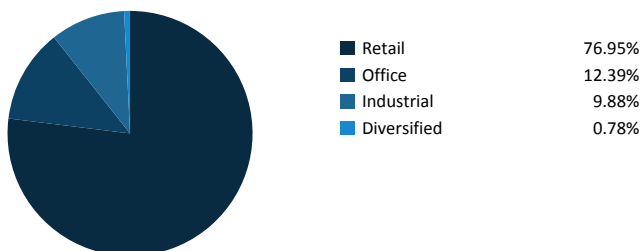

Asset Allocation



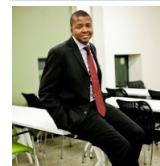
Sector Allocation

Commentary

September saw the US Dollar reign supreme as risk assets sold off with Bitcoin collapsing by 15%, below \$20k. The Federal Reserve increased rates by 75bps even though unemployment at 3.7% beat expectations at 3.5%. The ECB followed with 75bps points whilst the UK increased rates to 2.25%. The British queen died whilst Liz Truss enacted tax cuts which mainly benefitted the wealthy, thereby causing the pound to collapse, nearing parity with the US Dollar. South African markets followed global markets with the ALL Property Index down -6.48%.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.
